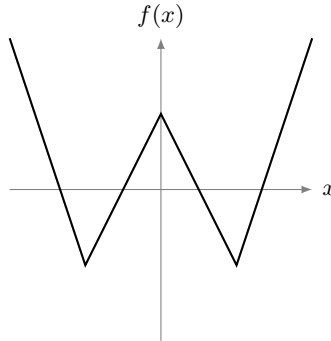

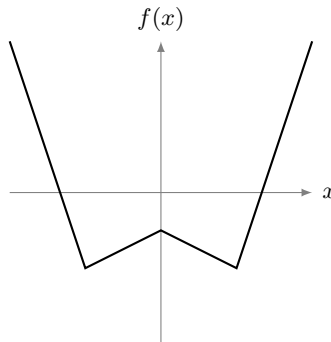

1. Are the following sets C convex? You may, where applicable and without proving it, use that $\|x\|_\infty := \max_i(|x_i|)$ is a convex function and that $\{x \in \mathbb{R}^n : x \geq 0\}$ is a convex set.

a. Let $C = \{x \in \mathbb{R} : f(x) \leq 0\}$ where f is given below: (1 p)



b. $C = \{x \in \mathbb{R} : f(x) \leq 0\}$ where f is given below: (1 p)



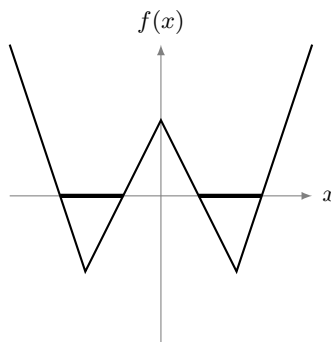
c. $C = \{x \in \mathbb{R}^n : x \geq 0 \text{ and } \|x\|_\infty \leq 1\}$. (1 p)

d. $C = \{x \in \mathbb{R}^n : x \geq 0 \text{ or } \|x\|_\infty \leq 1\}$. (1 p)

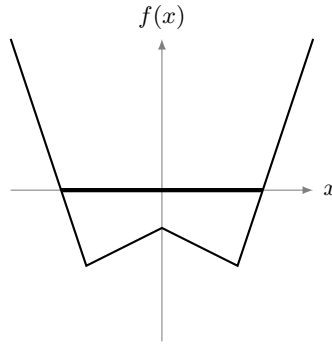
e. $C = \{(x, t) \in \mathbb{R}^n \times \mathbb{R} : \|x\|_\infty \leq t\}$. (1 p)

Solution

a. Nonconvex.



b. Convex.



- c. Convex. $x \geq 0$ convex and $\|x\|_\infty - 1 \leq 0$ convex since sublevelset of convex function. Intersection of convex functions is convex.
 - d. Nonconvex. Consider \mathbb{R}^2 and the points $x_1 = (-1, 1)$ and $x_2 = (0, 2)$. Then $\|x_1\|_\infty \leq 1$ and $x_2 \geq 0$, but the convex combination $x_3 = \frac{1}{2}(x_1 + x_2) = (-1/2, 3/2)$ is in none of the sets.
 - e. Convex. The set can be written as $\{(x, t) : \|x\|_\infty - t \leq 0\}$, which is the sublevel set of convex function, hence convex.
2. Are the following functions f convex? Where applicable, you may use convexity preserving operations or graphical arguments.
- a. $f(x) = \frac{1}{2} \begin{bmatrix} x_1 \\ x_2 \end{bmatrix}^T \begin{bmatrix} 1 & 0 \\ 0 & -1 \end{bmatrix} \begin{bmatrix} x_1 \\ x_2 \end{bmatrix}$ (1 p)
 - b. $f(x) = e^{\|x\|_1}$ where $x \in \mathbb{R}^n$ (1 p)
 - c. $f(x) = |e^{\|x\|_1}|$ where $x \in \mathbb{R}^n$ (1 p)
 - d. $f(x) = \max(f(x), g(x))$ where $f : \mathbb{R}^n \rightarrow \mathbb{R}, g : \mathbb{R}^n \rightarrow \mathbb{R}$ are both convex. (1 p)
 - e. $f(x) = \min(x^2, x)$ where $x \in \mathbb{R}$ (1 p)
 - f. $f(x) = \max(x^2, x, -x^2)$ where $x \in \mathbb{R}$ (1 p)
 - g. $f(x) = \max(x^2, x, 1 - x^2)$ where $x \in \mathbb{R}$ (1 p)

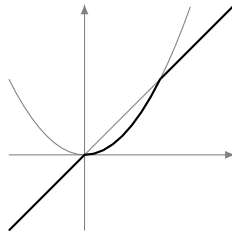
Solution

- a. Hessian is constant and symmetric, but not positive semidefinite (eigenvalues -1 and 1). Hence nonconvex.
- b. It is a composition between nondecreasing e^u and convex $\|x\|_1$, hence convex.
- c. Convex since $|e^{\|x\|_1}| = e^{\|x\|_1}$ which is convex due to **b.**
- d. Supremum (maximum) of convex functions is convexity preserving operation, hence convex. The epigraph is convex since

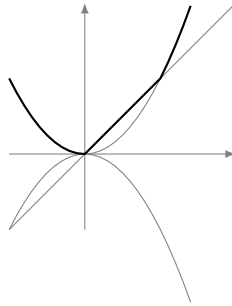
$$\begin{aligned} \text{epi}(\max(f, g)) &= \{(x, t) : \max(f(x), g(x)) \leq t\} = \{(x, t) : f(x) \leq t \text{ and } g(x) \leq t\} \\ &= \{(x, t) : f(x) \leq t\} \cap \{(x, t) : g(x) \leq t\} = \text{epi}f \cap \text{epi}g \end{aligned}$$

i.e., intersection of individual *convex* epigraphs, hence convex.

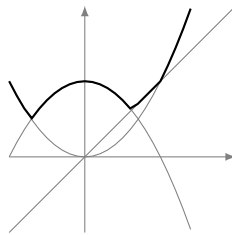
e. Not convex.



f. Convex.



g. Not convex.



3. Consider the following problem

$$\underset{u}{\text{minimize}} \max(h_1^T u, h_2^T u) + \frac{1}{2} \|u\|_2^2.$$

Show that u solves this if and only if (u, t) solves

$$\begin{aligned} \underset{u, t}{\text{minimize}} \quad & t + \frac{1}{2} \|u\|_2^2 \\ \text{subject to} \quad & h_1^T u \leq t \\ & h_2^T u \leq t \end{aligned}$$

(1 p)

Solution

Since $t \geq h_1^T u$ and $t \geq h_2^T u$ it must satisfy $t \geq \max(h_1^T u, h_2^T u)$ for all feasible (t, u) . Now, assume that an optimal pair (t^*, u^*) satisfies $t^* = \max(h_1^T u^*, h_2^T u^*) + \epsilon$, where $\epsilon > 0$ (i.e., $t^* > \max(h_1^T u^*, h_2^T u^*)$). Then $\tilde{t} = t^* - \epsilon$ achieves a lower cost (since t is in the objective and we minimize over t) and satisfies both constraints: $h_1^T u^* \leq \tilde{t}$ and $h_2^T u^* \leq \tilde{t}$. We conclude that the optimal pair (t^*, u^*) satisfies $t^* = \max(h_1^T u^*, h_2^T u^*)$. Hence the problems are equivalent.

4. Consider the following problem (that satisfies constraint qualification):

$$\underset{x}{\text{minimize}} \underbrace{\|Ax - b\|_1}_{f(Ax)} + \underbrace{\sum_{i=1}^n g_i(x_i)}_{g(x)}$$

where $A \in \mathbb{R}^{m \times n}$, $b \in \mathbb{R}^m$, all $g_i : \mathbb{R} \rightarrow \mathbb{R} \cup \{\infty\}$ are the same and satisfy

$$g_i(x_i) = \begin{cases} \frac{1}{2}x_i^2 & \text{if } x_i \in [-1, 1] \\ \infty & \text{else} \end{cases}$$

and $f(y) = \|y - b\|_1$ with dual problem

$$\underset{\mu}{\text{minimize}} f^*(\mu) + g^*(-A^T \mu).$$

- a. Compute the conjugate f^* . (1 p)
- b. Compute the conjugate g^* . (1 p)
- c. Can the primal problem be solved using the proximal gradient method? (1 p)
- d. Can the dual problem be solved using the proximal gradient method? (You don't need to have solved **a.** or **b.** to answer this.) (1 p)
- e. Assume a dual solution μ^* is known. Provide *one* simple condition that recovers a primal solution. (You don't need to have solved **a.** or **b.** to answer this, you can phrase the recovery in terms of functions f or g , or conjugates f^* and g^* .) (1 p)

Solution

- a. We first note that

$$f^*(s) = \sup_y (s^T y - \|y - b\|_1) = \sup_v (s^T (v + b) - \|v\|_1) = \sup_v (s^T v - \|v\|_1) + s^T b.$$

Therefore, we can compute the conjugate of $\|\cdot\|_1$ and then add $s^T b$.

We let $\hat{f}(y) = \sum_{i=1}^m |y_i|$, which implies $\hat{f}^*(s) = \sum_{i=1}^m \hat{f}_i^*(s)$ by separability of \hat{f} , where $\hat{f}_i(y_i) = |y_i|$. We have

$$\hat{f}_i^*(s_i) = \sup_{y_i} (s_i y_i - |y_i|).$$

There are many ways to compute the conjugate of 1D functions. We provide a proof that directly optimizes the definition for different s .

- For $s_i < -1$, let $y_i = t_- \leq 0$ with $t_- \rightarrow -\infty$, which gives

$$\hat{f}_i^*(s_i) = \sup_{y_i} (y_i s_i - |y_i|) \geq s_i t_- - |t_-| = (s_i + 1)t_- \rightarrow \infty$$

since $s_i < -1$.

- For $s_i > 1$, let $y_i = t_+ \leq 0$ with $t_+ \rightarrow \infty$, which gives

$$\hat{f}_i^*(s_i) = \sup_{y_i} (y_i s - |y_i|) \geq s_i t_+ - |t_+| = (s_i - 1)t_+ \rightarrow \infty$$

since $s_i > 1$.

- For $s_i \in [-1, 1]$, we have by Cauchy-Schwarz that $s_i y_i \leq |y_i| |s_i| \leq |y_i|$ for all y_i . Therefore $\hat{f}_i^*(s_i) = \sup_{y_i} s_i^T y_i - |y_i| \leq \sup_{y_i} |y_i| - |y_i| = 0$. Further, $\hat{f}_i^*(s_i) = \sup_{y_i} s_i y_i - |y_i| \geq \sup_{y_i} s_i 0 - 0 = 0$. Hence $\hat{f}_i^*(s_i) = 0$ for all $s_i \in [-1, 1]$.

The conjugate becomes

$$\hat{f}_i^*(s_i) = \begin{cases} 0 & \text{if } s_i \in [-1, 1] \\ \infty & \text{else} \end{cases}$$

i.e. $\hat{f}_i^*(s_i) = \iota_{[-1,1]}(s_i)$. This implies

$$f^*(s) = \hat{f}^*(s) + s^T b = \left(\sum_{i=1}^m \iota_{[-1,1]}(s_i) \right) + s^T b = \iota_{[-1,1]}(s) + s^T b.$$

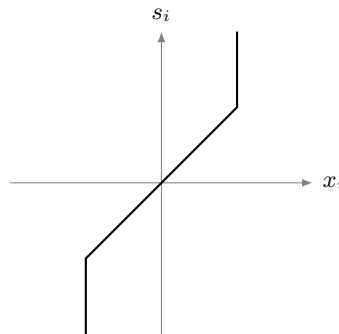
- b.** We have $g(x) = \sum_{i=1}^m g_i(x_i)$, which implies $g^*(s) = \sum_{i=1}^m g_i^*(s_i)$ by separability of g . We will compute the conjugate from the relation

$$g_i^*(s_i) = s_i x_i - g_i(x_i) \quad \text{if and only if} \quad s_i \in \partial g_i(x_i).$$

The subgradient of g_i is given by

$$\partial g_i(x_i) = \begin{cases} (-\infty, -1] & \text{if } x_i = -1 \\ x_i & \text{if } x_i \in (-1, 1) \\ [1, \infty) & \text{if } x_i = 1 \\ \emptyset & \text{else} \end{cases}$$

or in graphics



Therefore

- For $x_i = -1$: $g_i(x_i) = \frac{1}{2}$, $s_i \in (-\infty, -1]$, and

$$g_i^*(s_i) = s_i x_i - g_i(x_i) = -s_i - \frac{1}{2}$$

for $s_i \in (-\infty, -1]$.

- For $x_i \in (-1, 1)$: $g_i(x_i) = \frac{1}{2}x_i^2$, $s_i = x_i$, and

$$g_i^*(s_i) = s_i x_i - g_i(x_i) = s_i^2 - \frac{1}{2}x_i^2 = s_i^2 - \frac{1}{2}s_i^2 = \frac{1}{2}s_i^2$$

for $s_i \in (-1, 1)$.

- For $x_i = 1$: $g_i(x_i) = \frac{1}{2}$, $s_i \in [1, \infty)$, and

$$g_i^*(s_i) = s_i x_i - g_i(x_i) = s_i - \frac{1}{2}$$

for $s_i \in [1, \infty)$.

To conclude:

$$g^*(s) = \sum_{i=1}^n g_i(s_i) = \sum_{i=1}^n \begin{cases} -s_i - \frac{1}{2} & \text{if } s_i \leq -1 \\ \frac{1}{2}s_i^2 & \text{if } s_i \in [-1, 1] \\ s_i - \frac{1}{2} & \text{if } s_i \geq 1 \end{cases}$$

which is sum of Huber functions.

- c. No. None of the functions are smooth.
- d. Yes. Each g_i is strongly convex and so is g . Therefore g^* is smooth and so is $g^* \circ -A^T$. Therefore the proximal gradient method can be applied to the dual. In addition, f is separable and easy to prox on.
- e. By primal-dual optimality condition

$$x \in \partial g^*(-A^T \mu^*).$$

Since g is strongly convex, g^* is smooth, hence differentiable. Therefore $\partial g^*(-A^T \mu^*)$ is a singleton and must be the primal solution.

5. Consider the following constrained optimization problem

$$\underset{x}{\text{minimize}} f(x) + \iota_C(x),$$

where constraint qualification holds so that x^* solves the problem if and only if $0 \in \partial f(x^*) + \partial \iota_C(x^*)$. Assume you have solved the dual problem

$$\underset{\mu}{\text{minimize}} (f^*(\mu) + g^*(-\mu))$$

and found the optimal dual variable $\mu^* = 0$. Show that all primal optimal x^* are also solutions to the unconstrained minimization problem

$$\text{minimize } f(x)$$

using primal-dual optimality conditions and Fermat's rule. (1 p)

Solution

By primal-dual optimality conditions, we have that x^* is a solution if and only if

$$\mu^* \in \partial f(x^*) \quad \text{and} \quad -\mu^* \in \partial \iota_C(x^*)$$

Now, since $\mu^* = 0$, this implies $0 \in \partial f(x^*)$ which is Fermat's rule for minimizing $f(x)$.

6. Suppose that $f : \mathbb{R}^n \rightarrow \mathbb{R}$ is β -smooth for some $\beta > 0$. Show that one step of the gradient method $x_{k+1} = x_k - \gamma \nabla f(x_k)$ gives the following function value decrease guarantee

$$f(x_{k+1}) - f(x_k) \leq -\gamma(1 - \frac{\beta\gamma}{2}) \|\nabla f(x_k)\|_2^2.$$

Find the γ that gives the largest guaranteed function value decrease at any given iteration. (1 p)

Solution

Using descent lemma for points x_{k+1} and x_k and the gradient method iteration, we get

$$\begin{aligned} f(x_{k+1}) &\leq f(x_k) + \nabla f(x_k)^T (x_{k+1} - x_k) + \frac{\beta}{2} \|x_{k+1} - x_k\|_2^2 \\ &= f(x_k) - \gamma \nabla f(x_k)^T \nabla f(x_k) + \frac{\beta\gamma^2}{2} \|\nabla f(x_k)\|_2^2 \\ &= f(x_k) - \gamma(1 - \frac{\beta\gamma}{2}) \|\nabla f(x_k)\|_2^2 \end{aligned}$$

The function value decrease is upper bounded by

$$-\gamma(1 - \frac{\beta\gamma}{2}) \|\nabla f(x_k)\|_2^2.$$

Since $\|\nabla f(x_k)\|_2^2$ is fixed, this amounts to minimizing $h(\gamma) := -\gamma(1 - \frac{\beta\gamma}{2}) = -\gamma + \frac{\beta}{2}\gamma^2$. Since h is differentiable and convex in γ (linear plus convex quadratic), the minimum is found at zero gradient: $\nabla h(\gamma) = -1 + \beta\gamma = 0$, i.e., the optimal $\gamma = \frac{1}{\beta}$.
